ORDER REGARDING PARTIAL AMENDMENT OF OCCUPATIONAL HEALTH AND SAFETY PROCEDURE BDS-11 WORKS AT HEIGHT

1 February 2018, No TV1(1.2-1)-41 Juodeikiai Vill., Mažeikiai Distr. Municipality

- 1. I hereby a m e n d Items 4.8 and 6.1 of Occupational Health and Safety Procedure BSD-11 'Works at Height' (hereinafter the Procedure) as approved by the Order No.TV1(1.2-1)-461 dated 30 November 2017 of Public Company ORLEN Lietuva (hereinafter the Company) Director of Quality, Labor Safety and Environmental Control and restate them as follows:
- '4.8. **Work coordinator** employee of Company organizational unit that initiates the erection of scaffolds ordered by the Company or employee of contractor that initiates the erection of scaffolds ordered by the contractor.'
- '6.1. When ordering installation of scaffolds the following data must be indicated: scaffolds installation location, scaffolds load class, scaffolds working platform installation height and dimensions (length and width). Load class 2 is usually indicated for working on scaffolds. Where need arises to use higher loads on scaffolds, the work coordinator must coordinate this with scaffolding company and specify a higher class in the order.'
 - 2. Supplement the Procedure with Item 8.7 that reads as follows:
- '8.7. Where deemed necessary, use scaffolds designed for higher than 2 load class and inform the work coordinator thereof.'
 - 3. Establish that the present Order shall come into force on 12 February 2018.
- 4. Obligate the managers of Company organizational units to familiarize their subordinates with the present Order by 12 February 2018.
- 5. Establish that this Order is assigned to the area of Deputy Director of Quality, Labor Safety and Environmental Control.
- 6. As s i g n the designated Executive Office employee to familiarize with the present Order the organizational unit managers listed in the distribution index hereof.
